#### **Call to Order and Welcome**

The meeting of the Judicial Council of Georgia (Council) was called to order at 2:00 p.m. by Chief Justice Harold Melton. The Chief Justice administered the oath to Judge Kerri Carter and Judge Gregory Price as the newest Council members. Ms. Clanton called roll for Council members; staff and guests were instructed to submit their attendance to Ms. Robinson for the purposes of the minutes.

#### Adoption of Minutes – May 18, 2020

Chief Justice Melton directed the Council's attention to the minutes of the Emergency Session on May 18, 2020. A motion to approve the minutes was offered by Judge Weaver, with a second from Judge Jackson. No discussion was offered, and the motion was approved without opposition.

# COVID-19 Update and Discussion of Statewide Judicial Emergency Order by Judicial Council Members

Chief Justice Melton recognized Judge Shawn LaGrua, Chair of the Judicial COVID-19 Task Force, to provide an update on its work. The Task Force conducted the first meeting on May 19, 2020, at 10 a.m. The Strategic Plan Committee is working in conjunction with the Task Force, resulting in the production of a guide for courts as they move forward. Judge LaGrua recognized the Director of the AOC and staff for assisting in the creation of the Georgia Court Reopening Guide. The Council discussed the broad suggestions within the guide, and how to appropriately address the versatility in Georgia courts and circuits.

The Council discussed the continued tolling of deadlines. Presiding Justice David Nahmias provided clarification regarding the latest order to extend the Statewide Judicial Emergency, noting judges have the authority to reinstate deadlines as deemed appropriate. Chief Justice Melton advised Council members to share any concerns or forward those concerns to Ms. Clanton to ensure they are addressed. The Council discussed options to restart deadlines, requesting feedback from each council's leadership.

Chief Justice Melton reported the Statewide Judicial Emergency is anticipated to be extended again with authority to reset timelines given to judges, excluding statute-based timelines. The Council discussed ways to address the tolling of deadlines, including dispossessory filings in magistrate courts and how to further classify cases related to tolling deadlines.

Judge Anderson reported that an employee in the Dekalb County Magistrate Court has tested positive for COVID-19, and the Chief Justice noted the closure of the Floyd County courthouse for sanitization following a positive case in that court. Chief Justice Melton requested information be made available for Council members regarding subcommittee leadership for the COVID-19 Task Force.

State Bar of Georgia. Mr. Sutton reported notice was sent to Bar membership concerning damage sustained to the State Bar building on Friday night. The Business Court proposed rules were disseminated for comment on behalf of the State-wide Business Court. He further noted the Bar is available to assist in disseminating notice to Bar members for each class of court.

<u>Administrative Office of the Courts.</u> Director Clanton recognized Justice Boggs for his participation in the Judicial Council budget presentation.
