You will receive a copy of the trial calendar at least 20 days prior to the beginning of trials. IF NO PRETRIAL CONFERENCE IS DESIRED BY EITHER PARTY, AND THE PRETRIAL INFORMATION FORM HAS BEEN COMPLETED AND RETURNED WITHIN THE PRESCRIBED TIME, YOUR PRESENCE AT THE CALENDAR CALL IS NOT REQUIRED.

Please be sure to notify opposing counsel of the calendar call and ensure that opposing counsel is aware of the requirement of filing the pretrial information form.

Effective as of the date the consolidated pretrial is due, no amendments or further discovery shall be allowed except by order of the Court.
