### **Call to Order and Welcome**

The meeting of the Judicial Council of Georgia (Council) was called to order at 2:00 p.m. by Chief Justice Harold Melton. Ms. Clanton called roll for Council members; staff and guests were instructed to submit their attendance to Ms. Robinson for the purposes of the minutes. The Chief Justice administered the oath to Judge Wade Padgett as the newest Council member. Chief Justice Melton also congratulated Judge Amero as the new president of the Council of Superior Court Judges.

#### Adoption of Minutes – April 24, 2020

Chief Justice Melton directed the Council's attention to the minutes of the General Session on April 24, 2020. A motion to approve the minutes was offered by Presiding Justice Nahmias, with a second from Judge Barker. No discussion was offered, and the motion was approved without opposition.

# COVID-19 Update and Discussion of Statewide Judicial Emergency Order by Judicial Council Members

Chief Justice Melton reported there are currently three town hall meetings scheduled. The landlord-tenant summit has been canceled and Chief Justice Melton recognized Judge Barker and Ms. Karounos for their contributions in planning the summit. The Council of Municipal Court Judges and the Council of State Courts Judge town hall meetings are scheduled for Tuesday, May 5, 2020. A town hall meeting is scheduled with the Council of Superior Court Clerks for Thursday, May 7, 2020.

The National Center for State Courts has identified a vendor for courts to order 3-ply and KN95 masks. Members should contact Drew Townsend at the AOC for details.

The Supreme Court issued a press release announcing the extension of the Statewide Judicial Emergency. The order will include reference to the guidance previously issued. Justice Blackwell reported on the inclusion of guidance on the tolling of terms of court; specifically, deadlines for trying a defendant under a speedy trial demand, motions for reconsideration, and motions to withdraw a guilty plea. The guidance notes any term of court interrupted by the judicial emergency would not count toward any deadline. Justice Blackwell also reported that a working group of superior court judges provided guidance to consider in grand jury management during the tolling period. The guidance given includes the recognition that there is essential and exceptional business that may require the convening of a grand jury to take up an issue. There needs to be a mechanism by which to convene a grand jury in those instances. There exists local law in some counties that allows for holdover of grand juries from the prior regular term, so a court should first check to see if there is local authorization in their particular county. If that is not the case in a particular county, the recommendation is that the superior court judges to compel the attendance of grand jurors of a previous term or to draw new jurors (see OCGA § 15-6-20). Chief

Justice Melton thanked Justice Blackwell and noted that, in absence of opposition, this guidance would be posted online after the meeting.

Chief Justice Melton reported the declaration extension will include an emphasis on video conferences; a draft rule has been circulated and issued for public comment and feedback. The order will also emphasize that jury trials are suspended, as are grand juries. The order explicitly notes that judges have the authority to compel attendance in video conferences. When in-court proceedings are conducted they must be in accordance with strict compliance with local, state, and CDC guidelines. Because of the variance in effect COVID-19 has on different areas, compliance must be met at each level. Local chief judges are authorized to impose greater restrictions if needed. Chief Justice Melton reported the draft order includes express language for courts to impose new scheduling orders and to restart scheduling orders to continue the movement of cases.

To identify a way to move forward, a judicial task force will be created to include representatives from each class of court, prosecutors, public defenders, sheriffs, and clerks to have a collaborative conversation about these nuanced issues. Council members discussed solutions to address the lack of available technology to participate in video conferencing, the lift on the prohibition of in-person hearings, the possibility of an additional extension to the judicial order, courthouse logistics concerning in-person proceedings, and how to proceed with probates.

Chairman Andy Welch of the Georgia House of Representatives provided a report on the state of the Fiscal Year 2021 budget. The House and Senate Appropriations leadership, along with the Governor's Office of Planning and Budget, have agreed on a 14 percent reduction to be requested from all state agencies. The 14 percent reduction will be based on the adopted Fiscal Year 2020 base budget; the judiciary is asked to review the submitted Fiscal Year 2021 budget and adjust it to get as close to the fourteen percent reduction as possible.
