Call to Order and Welcome

The meeting of the Judicial Council of Georgia (Council) was called to order at 2:00 p.m. by Chief Justice Harold Melton. The Chief Justice administered the oath to Judge W. James Sizemore as the newest Council member. Ms. Clanton called roll for Council members; staff and guests were instructed to submit their attendance to Ms. Robinson for the purposes of the minutes.

Adoption of Minutes – May 4, 2020

Chief Justice Melton directed the Council’s attention to the minutes of the Emergency Session on May 4, 2020. A motion to approve the minutes was offered by Presiding Justice Nahmias, with a second from Judge Weaver. No discussion was offered, and the motion was approved without opposition.

COVID-19 Update and Discussion of Statewide Judicial Emergency Order by Judicial Council Members

Chief Justice Melton reported on the three town hall meetings, noting there were 63 judges in attendance at the Council of Municipal Court Judges town hall; 92 judges in attendance at the Council of State Court Judges town hall; and 68 Superior Court clerks at the Council of Superior Court Clerks town hall. Chief Justice Melton recognized Judge McClelland, Judge Samuels, Mr. Mike Holiman, Judge Barker, and Ms. Karounos for their efforts planning the town hall meetings.

Chief Justice Melton directed attendees to the draft Second Order Extending the Statewide Judicial Emergency, noting it has been circulated for comment. Chief Justice Melton discussed proposed changes to be incorporated into the final order. To address concerns from Council members concerning barriers to entry and detailed plans to reopen courts for extensive in-person proceedings, Chief Justice Melton reported Judge Shawn LaGrúa is working on a bench card to provide guidance to address courthouse access. The task force announced at the last Council meeting will be chaired by Judge LaGrúa; Council members were directed to forward designees to Director Clanton. The Council discussed challenges that may exist at the expiration of the Statewide Judicial Emergency, including speedy trial deadlines and clarification on grand juries.

The Georgia House and Senate Appropriations Committees held a joint hearing last week, with presentations from Dr. Jeffrey Dorfman, State Economist, and Mr. Kelly Farr, OPB Director. Both reiterated the budget outlook information provided by Chairman Welch at the May 4 Council meeting.

The proposed Draft Uniform Superior Court Rule 9.1 Telephone or Video Conferencing revisions were circulated for comment; 188 comments were received and are being reviewed for consideration.

Council of State Court Judges. Judge McClelland expressed gratitude for the opportunity to meet with Chief Justice Melton and Presiding Justice Nahmias during the town hall meeting. Council of Probate Court Judges. No report was provided.

Council of Magistrate Court Judges. No report was provided.

Council of Municipal Court Judges. Judge Samuels expressed gratitude for the participation of Presiding Justice Nahmias and Chief Justice Melton in the town hall meeting. He also reported municipal courts are exploring ways to expand services.

State Bar of Georgia. No report was provided.

Administrative Office of the Courts. Director Clanton reported the AOC continues to remain fully functional with senior staff rotating in the office.

The program co-chaired by Ms. Rebecca Grist and Ms. Claudia Saari is scheduled for Noon, June 11, 2020.

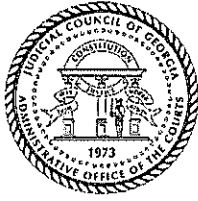

Judicial COVID-19 Task Force

In accordance with the Bylaws of the Judicial Council, ad hoc committees exist to address issues of limited scope and duration, and the Judicial Council Chair shall create and charge ad hoc committees as are necessary to conduct the business of the Judicial Council.

Therefore, I hereby establish the Judicial COVID-19 Task Force, as an ad hoc committee of the Judicial Council, with the mission of assisting courts in conducting remote proceedings and in restoring more in-court proceedings, in particular jury trials and grand jury proceedings. The Task Force will include judges from the various classes of court and will obtain input from key stakeholders including the State Bar of Georgia, prosecutors and public defenders, civil plaintiff and defense attorneys, court clerks, sheriffs, and the public.

The following members are hereby appointed to the Judicial COVID-19 Task Force:

- Judge Shawn LaGrua, Fulton County Superior Court, Chair
- Justice of the Supreme Court of Georgia, chosen by the Chief Justice
- Court of Appeals Judge, chosen by the Chief Judge of the Court of Appeals
- Georgia State-wide Business Court Judge
- Judge of an Accountability Court, chosen by the President of the Council of Accountability Courts
- State Court Judge, chosen by the President of the Council of State Court Judges
- Juvenile Court Judge, chosen by the President of the Council of Juvenile Court Judges
- Probate Court Judge, chosen by the President of the Council of Probate Court Judges
- Magistrate Court Judge, chosen by the President of the Council of Magistrate Court Judges
- Municipal Court Judge, chosen by the President of the Council of Municipal Court Judges
- Member of the State Bar of Georgia, chosen by the President of the State Bar
- Superior Court Clerk, chosen by the President of the Council of Superior Court Clerks

In addition, designees from the following organizations are hereby appointed as advisory members to the Judicial COVID-19 Task Force:

Committee membership may include additional advisory members appointed, as needed, by the Task Force Chair. Advisory members may be heard but shall not be entitled to vote.

The Administrative Office of the Courts shall provide staff support to this Task Force. Recommendations from the Task Force shall be presented to the Judicial Council and Supreme Court of Georgia for consideration. The Task Force shall exist from the date of this order until June 30, 2021.
