

## Password Reset Option

## New Search and Sort Options

The filtering and sort options in the latest version of JDEX have been updated. Report results can be auto filtered in order to find results quickly. In order to filter the juvenile's information, first move the mouse over the category name in the column header. Once you begin typing the filtering criteria into the search box, the results will appear in real time. Search results can also be sorted by ascending or descending order by clicking on the up and down arrows. To reset the report results, select "Reset Filter".


