THIRD ORDER ADDRESSING JUDICIAL EMERGENCY

On March 14, 2020, to combat the severe public health emergency posed by Covid-19, the Honorable Harold D. Melton, Chief Justice of the Supreme Court of the State of Georgia issued an Order Declaring a Judicial Emergency in all Georgia Counties under the provisions of O.C.G.A § 38-3-61. This original Order, set to expire on April 13, 2020, limited Court proceedings to only essential functions and tolled filing and timing requirements in civil, criminal and administrative matters. In response to the Chief Justice's Order, the Honorable John Simpson, Chief Judge of the Superior Court of the Coweta Judicial Circuit, issued an order declaring a Judicial Emergency on the local level, pursuant to O.C.G.A. § 38-3-61 and O.C.G.A. § 38-3-62.

Prior to the expiration of the original Emergency Order, on April 6, 200, Chief Justice Melton issued a second order extending the Judicial Emergency until May 13, 2020; in this extension order, the Chief Justice encouraged use of teleconferencing and videoconferencing technologies to manage cases remotely.

On May 12, 2020, Chief Justice Harold D. Melton issued a third emergency order, extending the judicial emergency through June 13, 2020. In this order, Justice Melton encourages the use of video conference hearings as follows:

All courts should continue to use and increase the use of technology to conduct remote judicial proceedings as a preferred alternative to in person proceedings, both to ensure that essential court functions are continued and to conduct non-essential proceedings to limit the backlog of such matters when the judicial emergency is terminated. Courts should understand and utilize the authority provided by the emergency amendments made to court rules on video conferences and teleconferences. Courts may compel the participation of litigants, lawyers, witnesses, and other essential personnel in remote judicial proceedings, including civil non-jury trials and other non-jury adjudicative proceedings,

where allowed by court rules (including emergency amendments thereto). Such proceedings, however, must be consistent with public health guidance, must not impose undue burdens on participants, and must not be prohibited by the requirements of the United States or Georgia constitutions or applicable statutes or court rules. In civil, criminal, and juvenile proceedings, parties may expressly consent in the record to remote proceedings not otherwise authorized and affirmatively waive otherwise applicable legal requirements. Courts must ensure the public's right of access to judicial proceedings and, unless affirmatively waived in the record, a criminal defendant's rights to confrontation and open courtrooms.

Under the powers of O.C.G.A. §§ 38-3-60-62, and to carry out the Order of the Honorable Chief Justice, starting June 1, 2020, the following shall apply:

- I. The 2020 Calendar for the Superior Courts of Carroll, Heard, and Troup is hereby revoked and replaced by the attached Exhibit A. The Coweta Superior Court Calendar as it applies to Judges Simpson, Hamrick, Hightower, Blackmon, and Baker is revoked and replaced by the calendar in Exhibit A. Judge Emory Palmer and Judge Travis Sakrison are presenting a scheduling order for the remaining cases in Coweta and Meriwether counties. All changes to the calendars are endorsed by all of the superior court judges of the Coweta Circuit.
- II. There will be a preference for conducting cases online whenever possible. Anyone objecting to the hearing going forward by video conference shall make the objection known to the judge prior to the start of the hearing and the judge shall rule upon the objection.
- III. The Clerk of the Superior Court shall create and post calendars on the Clerk's website. The public shall be given instructions on viewing hearings using online platforms.
- IV. Parties and attorneys shall wear appropriate clothing for court during online hearings.

V. Unless otherwise ordered by a superior court judge, all individuals entering the Courthouse will follow the recommendations issued by the CDC and Georgia DPH about social distancing, including but not limited to, wearing a mask or cloth face covering over the nose and mouth at all times on Courthouse property, frequent handwashing, and maintaining a minimum of six feet of space between (people or individuals not of the same household). VI. Criminal Guilty Pleas:

In Carroll County, criminal pleas, bonds, and probation revocations shall be conducted by video conferencing. Cases will be placed on calendars by the assigned judge or the assigned judge's assistant. The following must occur prior to a plea hearing:

- 1. The Plea Proceeding Record and the Indictment shall be signed;
- 2. The Plea Agreement between the state and the defense shall be filed with the Clerk.

In Troup County and Heard County, cases will be heard using online platforms whenever possible.

VII. Civil Cases:

In Carroll County, civil cases will be heard by video conferencing. All exhibits shall be submitted to the Clerk's Office prior to hearing, and the exhibits will be presented to the court in electronic format. All video conference hearings will be presented in accordance with USCR 9.1.

In Troup County and Heard County, civil cases will be heard using online platforms whenever possible.

VIII. Civil Domestic Violence

Carroll County civil domestic violence calendars shall be heard by Judge John Simpson.

IX. Conclusion

Going forward superior court judges will be giving instructions on expanding services and following all guidelines provided by the Centers For Disease Control (CDC), the Georgia Department of Public Health (DPH), and local health departments.

IN THE SUPERIOR COURTS OF THE COWETA JUDICIAL CIRCUIT STATE OF GEORGIA

ORDER RESTARTING GRAND JURY PROCEEDINGS

The Chief Judge of the Coweta Judicial Circuit hereby authorizes that Grand Juries begin operations in the Coweta Circuit. All CDC and Georgia Public Health Guidelines shall be followed (including the wearing of a suitable mask or face covering that covers the nose and mouth; maintaining six feet of distance from other individuals; requiring temperature check and covid checklist survey before entry). The requirements of Chief Justice Melton's sixth Emergency Extension Order shall be followed. The initial supervising judges of the Grand Juries are as follows:

- a. Carroll County Judge John Simpson
- b. Coweta County Judge Emory Palmer
- c. Troup County Judge Judge Nina Markette Baker

The Clerk of Court shall use the usual random selection method for summoning jurors. Jurors shall receive staggered times to appear on the summons, and are requested to not come to the courthouse early.

Juror Excusals:

A. Juror Qualification Excusals (O.C.G.A. § 15-12-60):

Individuals falling in any of the below-listed classes are ineligible to serve on the Grand Jury in Carroll County and shall be excused from service when any of the following apply:

- i. No longer a resident of Carroll county;
- ii. Have a Felony conviction(without having rights restored);
- iii. Having held elected office in the past two years; or

iv. Incompetent due to mental illness or intellectual disability.

B. Statutory Juror Excusals (O.C.G.A. § 15–12–1.1):

- i. Enrolled in Full-time college, university, vocational, or other post-secondary school;
- ii. Primary caregiver having active care and custody of a child six years of age or younger and having no reasonable alternative for child care;
- iii. Primary teacher in a home study program, or parent or caregiver, responsible for supervision of remote learning for an elementary or middle school student;
- iv. Primary caregiver of someone over six years of age when such person has physical or cognitive limitations such that the person cannot be left unattended and you have no reasonable alternative for child care;
- v. Engaged in work necessary to the public health;
- vi. Over the age of 70 years; or
- vii. On ordered military service.

C. Covid-19 Related Excusals:

Covid-19 related excusals will be granted at the discretion of the supervising judge.

Clerks of Court shall provide affidavits and assist jurors with the preparation of affidavits in carrying out this order.
