If either side desires a comprehensive pretrial hearing, please contact Leann Ivester to schedule. **IF NO PRETRIAL CONFERENCE IS DESIRED BY EITHER PARTY, AND THE PRETRIAL INFORMATION FORM HAS BEEN COMPLETED AND RETURNED WITHIN THE PRESCRIBED TIME, YOUR PRESENCE AT THE CALENDAR CALL IS NOT REQUIRED.**

If there has been a demand for a jury trial, a consolidated pretrial must be filed by the date indicated below. You will receive a copy of the trial calendar at least 20 days prior to the beginning of trials. Effective as of the date the consolidated pretrial is due, no amendments or further discovery shall be allowed except by order of the Court.
