SENTENCE

WHEREAS the defendant in the above-styled case ( ) pled (guilty) (nolo contendere) to the offense(s) stated herein, and said plea having been accepted by the Court, ( ) been found guilty of the offense(s) stated herein, it is considered, ordered and adjudged that the defendant pay a fine of \$\_\_\_\_\_, Court costs of \$\_\_\_\_\_, and \$\_\_\_\_\_ restitution to Clayton County for cost of appointed counsel and all lawfully required surcharges and be confined for a term of \_\_\_\_\_ (days) (months) in the Clayton County jail or such other place as the defendant may legally be confined, such time to be computed as provided by law.

- ( ) This sentence may be served on the Work Release Program subject to all rules attendant thereto.
- ( ) This sentence shall run consecutively to Case No \_\_\_\_\_.
- ( ) Provided, that after the service of \_\_\_\_\_ (hours) (days) (months) the confinement shall be (suspended) (probated) upon payment of the above-stated fine, costs and restitution plus \$\_\_\_\_\_ victim's restitution, provided the defendant shall not again violate the laws of the State of Georgia.
- ( ) Provided, that the confinement specified shall be (suspended) (probated) on payment of the fine, costs and restitution above-stated plus \$\_\_\_\_\_ victim's restitution, provided the defendant shall not again violate the laws of the State of Georgia.

If probated, the defendant shall comply with all conditions of probation appearing hereon, in any addendum hereto, and in the Court's General Conditions of probation to be supplied by the probation officer.

- ( ) As a condition of the sentence, the defendant is ordered to serve \_\_\_\_\_ consecutive weekends in the Clayton County Jail. A "weekend" is defined as \_\_\_\_\_m. \_\_\_\_\_ to \_\_\_\_\_m. \_\_\_\_\_ beginning \_\_\_\_\_.
- ( ) Upon completion of all special conditions of probation by the defendant, the balance of the sentence shall be suspended on the condition the defendant shall not violate the laws of the State of Georgia.
- ( ) The fine, costs and restitution provided herein may be paid by the defendant by \_\_\_\_\_ through the Suspended Sentence Division of the Clerk of this Court.
- ( ) Provided that the fine and jail sentence shall be suspended on the condition that the defendant report to the Clayton County Child Support Recovery Unit within 10 days from this date, enter into an order to pay support for his minor child(ren) and fully comply with said order of support.

( ) FIRST OFFENDER. Provided, that the fine is declared to be additional court costs and the confinement specified is imposed pursuant to the Act for Probation of First Offenders (O.C.G.A. §42-8-60 or 16-13-2) with no adjudication of guilt being entered and shall be probated according to all conditions of probation imposed.

- ( ) Provided, the defendant shall consume no alcoholic beverage of any kind or character, nor in any quantity whatsoever. He/she shall submit to random tests of his/her blood, breath, urine, or other bodily substances. The presence of any alcohol or non-prescribed controlled substance shall constitute a violation of this probated sentence.
- ( ) Provided, the defendant shall, within 10 days of the date of this sentence, go to the Clayton Mental Health Center or \_\_\_\_\_ for evaluation, and fully participate in and complete any program of counselling and/or treatment which may be prescribed.
- ( ) Provided, the defendant performs \_\_\_\_\_ hours of community service as determined by the probation office.
- ( ) Provided, the defendant shall have no contact of any kind or character, direct or indirect, in person or otherwise, with the victim or any member of the victim's family.
- ( ) Provided, defendant shall not go upon the premises named in the accusation.
- ( ) Provided, the defendant shall take antabuse on a daily basis as prescribed unless medically prohibited from doing so, and attend not less than \_\_\_\_\_ sessions of alcoholics anonymous per week and provide monthly proof thereof to the probation supervising officer.
- ( ) Defendant may report to probation by phone.
